CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) (NO. 3) ORDER 2020

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) (No. 3) Order 2020**.

(2) **This Order comes into operation on 17 October 2020.**

Amendment of Second Schedule

2. The Customs (Prohibition of Imports) Order 2017 [P.U. (A) 103/2017] is amended in the Second Schedule, in Part I, in relation to item 2, by inserting after subitem (4) in column (2) and the particulars against it in columns (3) and (4) the following subitems and particulars:
