2. Kindly be informed, DVS has received a new requirement from the People's Democratic Republic of Algeria for the exportation of foodstuffs product from Malaysia to Algeria. The exportation food products under Department Veterinary Services, Malaysia jurisdiction shall comply with the microbiological criteria as published in the Official Gazette N39 of 2 July 2017.

3. The food products under DVS jurisdiction are milk and dairy product, red and white meat derivatives, animal fats, eggs and egg products. Attached herewith the official gazette of microbial criteria by the People's Democratic Republic of Algeria for your kind attention.
